Should U.S. ham tests be given abroad?

A couple of weeks ago, I received an e-mail from a reader who wanted my opinion about a thread on the HamRadioHelpGroup mailing list. The e-mail that started the discussion was a message from an American living in Italy who wanted to take the Technician Class exam. In her e-mail, she told of her troubles finding a test session, and then when she did find one, what she perceived as "irregularities" in the testing process. Reading the thread was a little disconcerting, and I blogged about this issue (<u>http://www.kb6nu.com/u-s-amateur-radio-license-exams-given-outside-u-s/</u>).

I understand why foreign national go to the trouble of taking the U.S. license exam. Some of them even buy my study guides. About a year ago, for example, I swapped some e-mail with a guy from Malaysia about why he purchased my study guide and why he wanted a U.S. license. He said that it was because a neighboring country offered reciprocal operating privileges to U.S. licensees, but not Malaysian licensees! He mentioned that he tested for the license in Thailand.

Basically, my Malaysian friend was using the U.S. licensing process to circumvent the Malaysian licensing process. Australians seem to do this, too. Apparently, according to one of the VKs who commented on the thread, getting a U.S. Tech license is easier than testing for an Australian Foundation license. So, some Australians get a U.S. Tech license first, then get the Australian government to issue them a VK Foundation license based on the reciprocal operating agreement between the U.S. and Australia.

Another reason that some outside the U.S. obtain U.S. amateur radio licenses is the challenge. That's the reason Martin Butler, M0MRB/W9ICQ, of ICQPodcast fame, gave when I spoke to him about this recently.

Are these reasons "good enough" to continue this program of licensing non-U.S. citizens? My first reaction was that no, it's not good enough, and I questioned whether or not the ARRL VEC should sanction non-U.S. VEs and whether or not the FCC should even allow testing outside of the United States.

I didn't see the need for conducting these test sessions or the desirability (to the U.S.) of licensing foreign nationals. I reasoned that not only was there a greater possibility of test fraud, this program could lead to foreign authorities claiming that the U.S. was meddling in their affairs.

This post garnered a lot of comments. Several of them took me to task for voicing this opinion and were in favor keeping the current licensing program in place. There were a variety of reasons.

One of the reasons in favor of using the U.S. licensing process is that in many countries, amateur radio license exam sessions are not very frequent. Another is that they often are quite expensive. This creates an artificial barrier to getting an amateur radio license. Using the U.S. licensing system breaks through this barrier and allows many more to enjoy amateur radio.

Of course, for everything to be on the up and up, the foreign authorities would have to condone the use of U.S. license tests. Apparently, this is the case in Thailand and Australia. I don't know about Italy, but I'm guessing that the authorities there don't really care about Italians obtaining U.S. licenses.

Perhaps the best comment came from Thida, HS1ASC/KH6ASC. He noted that the tests in Thailand were administered very strictly, and says, "The U.S. may lose some callsigns, but what the U.S. and U.S. hams get from us is goodwill, very positive feeling. Everyone who gets U.S. license is so proud, and others look at them respectfully." Since Part 97.1(e) lists as one of the purposes of amateur radio, "Continuation and extension of the amateur's unique ability to enhance international goodwill," I'm now all in favor of offering U.S. ham tests abroad.

Digital Mesh News by Orv W6BI

The AREDN group continues to develop the next version of their digital mesh code. They've knocked out almost all of the outstanding issues, but no release date has been announced yet. The updated firmware version will support newer versions of the Ubiquiti product line and implement a new user interface that will allow more flexibility in configuring the equipment.

Farther south, Orange County has linked up with San Bernardino County via a 5 GHz link. From Joe, AE6XE: "Announcing a live link today from Orange County at Pleasants Pk with Yucaipa, CA in San Bernardino County. Everyone was excited to see the TxMbps readings show solid links of 26Mbps in both directions. KI6BX-Keith and AI6SW-Shane are making a big splash in SBD County " So the mesh backbone continues to grow and cover new areas.

Locally last weekend (10/1, specifically) Dave KM6FQ and I went to the old Simi Valley repeater site located on the north end of Sycamore. We cleaned trash out of the cabinet and removed the Hustler G6 antenna that had been used on the repeater when it was sited there. We replaced it with a Ubiguiti Nanostation loco M2 running AREDN code. It's on the local standard channel of -2 (2397 MHz), with the local SSID of "BroadbandHamnet", pointed at about 110 degrees.

Hooked to it is a camera pointing ESE. At the moment the camera is just sitting on top of the cabinet but we will put it on the top of the tower during our next maintenance visit. We may point it in a different direction, too.

Here's a screenshot of the camera, taken at dusk:



Eventually we'd like to upgrade the link from 2 GHZ with a 10 MHz bandwidth to a 5 GHz node with a 20 MHz bandwidth, which will allow us to get better video quality.

Speaking of video, we hope to eventually upgrade the current camera to a PTZ camera so we can direct it at any brushfires that might be threatening the area. (Funding is an issue at the moment).

In other local news Simi Valley Hospital expects to see some progress in their commitment to provide network cables and nodes to go along with the existing ham presence there in the next couple of weeks.

We've established a new net to discuss digital mesh stuff - it's on the WD6EBY linked repeaters, every Wednesday at 7:30 p.m. If you have guestions about digital mesh or are just interested, feel free to check in!

General Membership Meeting, September 8, 2016

- <u>Call to Order</u>: Standing in for President, Frank Valdez, KI6OQ, Newsletter Editor Joe Partlow, W6JWP, called the meeting to order at 7:02pm. Joe welcomed everyone to the meeting, held at the Simi Valley Senior Center. There was a recitation of The Pledge of Allegiance. 9 Officers and Board Members/Advisors were present. The total attendance was 28, with 5 visitors.
- Introductions: A brief round of introductions was made. Guests included: Kyle Evans, KK6IES, Randy Phillips, W6OKK, Ron Nelson, KM6ETM, Steve Hudson, KI6BSQ and Greg Hardynas.
- <u>Announcements</u>: Spencer Smith, N6IWY, mentioned that he has two remaining items available from the estate sale that was shown in the August Newsletter. Steve King, KE6WEZ, said volunteers are needed for the "Share the Road Ride" on Saturday, October 8. Steve mentioned that Lisa Trent and Chris are supporting research efforts for a cure for leukemia at a triathlon event in Hawaii. Bill Everett said there will be an Emergency Expo at LA Fire Station #87 in the San Fernando Valley. Joe said that our next Club picnic will be planned for some time in October.
- Program: Joe Partlow, W6JWP, introduced Orv Beach, W6BI, who made a presentation to bring us up to date with "What's new in Mesh Networking". He began by showing a map indicating the locations of active Mesh stations in our region of Southern California. There is a plan to have a "backbone" system of stations to extend coverage for SoCal. He showed pictures of how his own antenna setup has changed over time. Orv described the projects for the immediate 6 to 12 month time frame and then longer term over the next 2 years. Plans include getting Mesh equipment into more emergency agency locations and getting backup power for Chatsworth Peak, Laguna Peak and the backbone sites. He hopes that more hams will become active Mesh users. To help build interest, a voice net is being planned to cover digital topics and Mesh networking. Orv mentioned that they hope to put up a mesh node at the old Simi Valley Repeater Association repeater site. After the presentation ended with a question and answer session, Joe thanked Orv and presented him with a certificate of appreciation from the Simi Settlers.
- <u>Break</u>: Following the program a 25-minute break was taken with refreshments provided by Bill Everett, KI6KSV.
- <u>Member Drawing</u>: The winning name in the progressive Membership drawing was Richard Carter, KJ6NXC, who was not present to win the \$30 prize. Therefore, the amount will be increased to \$40 for our next regular meeting on October 13, 2016. Members must be present to win, and the prize grows by \$10 each month it is unclaimed.
- <u>Prize Raffle</u>: After the prize raffle, the Grand Prize, a power screwdriver, was won by Bill Costello, AG6XK. (Secretary's note: The "Grand Prize" at the August 11 meeting raffle was a large flashlight won by Jim Veronica, WA6NXK).
